**ORDERS BY THE GOVERNOR OF ASSAM**

**NOTIFICATION**

Dated Dispur the 6<sup>th</sup> June, 2011

PE. 66/ 2010/ 153: In continuation of this Department's Notification issued vide No. PE. 66/ 2010/ 94 dated 22-02-2011, the Governor of Assam is further pleased to order that the Revised Pay Bands and the corresponding Grade Pay recommended by the State Level Public Enterprises Pay Revision Committee, 2010 and subsequently the revised Grade Pay in case of Pay Bands 1 & 2 based on the Resolution on the Report of the Anomaly Committee issued vide Notification No. FPC. 109/ 2009/ 3 dated 19-02-2011 respectively are applicable to the employees of the following two SLPEs placed under category – "A".

1. Assam Gas Company Ltd.
2. Assam Co-operative Jute Mills Ltd.

The Board of Directors of the above SLPEs are authorised and shall approve the revision of pay structures, other allowances as applicable and other issues arises thereon, subject to the conditions that:-

1. The new pay structures furnished at Annexure - "I" are applicable and fixation of revised pay shall be fixed notionally as on 01-01-2006 but no arrears would be paid for the period between 01-01-2006 to 30-09-2008.
2. Other relevant recommendations of the Pay Revision Committee shall be applicable to the category – "A" SLPEs as well as the provisions as laid down in the Assam Services (Revision of Pay) Rules, 2010 that are applicable to the employees of the State Government.
3. While allowing revision of pay structures, changes of any allowances and any anomalies arises thereon may be settled by the Board of Directors and need **not** be referred to the State Government in the Finance Department for approval.
4. The Revised Grade Pay in case of Pay Band '1' & '2' over the respective grade pay furnished at Annexure – "I" shall be applicable from 1<sup>st</sup> January, 2011 only.

This issues in pursuance of the Cabinet decision dated 03-05-2010 and 26-02-2011 communicated by the Finance (PRU) Department vide their No. FPC. 16/ 2007/ Pt/ 82 dated 11-05-2010 and UO endorsement No. FPC. 38/ 2011 dated 21-03-2011 and concurrence of Finance Deptt. communicated vide UO endorsement No. FPC. 88/ 2011 dated 25-05-2011.
